NOTICE OF MEETINGS AND PUBLIC HEARING
PROPOSED ORDINANCE

THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA WILL CONSIDER THE FOLLOWING PROPOSED ORDINANCE AT THEIR MEETING ON FEBRUARY 23, 2021 AT 6:00 PM CITY HALL COMMISSION CHAMBERS, 701 S.W. 71ST AVENUE, NORTH LAUDERDALE, FLORIDA, 33068. ANYONE WISHING TO SPEAK ON THE ORDINANCE WILL BE HEARD AT THAT TIME. ORDINANCES MAY BE VIEWED AND READ IN THEIR ENTIRETY ELECTRONICALLY OR BY PRINTED COPY BY CONTACTING THE OFFICE OF THE CITY CLERK AT THE ABOVE ADDRESS, DAILY FROM 7 A.M. UNTIL 6 P.M., MONDAY THROUGH THURSDAY.

THE FOLLOWING MEETING WILL BE CONDUCTED AS A “VIRTUAL” CITY COMMISSION MEETINGS AND OTHER REGULARLY SCHEDULED PUBLIC MEETINGS, AS PROVIDED BY LAW, UTILIZING COMMUNICATIONS MEDIA TECHNOLOGY (“CMT”), IN ACCORDANCE WITH CH. 286, F.S., AND THE CITY OF NORTH LAUDERDALE EMERGENCY ORDINANCE #20-11-1413, AUTHORIZING THE CITY COMMISSION TO ARRANGE FOR PUBLIC MEETINGS BY USE OF CMT AND FOR ATTENDANCE BY USE OF SUCH TECHNOLOGY BY ELECTED AND APPOINTED OFFICIALS DURING A DECLARED PUBLIC HEALTH EMERGENCY. THE CONDUCTING OF VIRTUAL MEETINGS IS SUBJECT TO POTENTIAL CHANGE OR MODIFICATION AND REVERSION TO NON-VIRTUAL, IN-PERSON PUBLIC MEETINGS, DEPENDENT UPON EXECUTIVE ORDERS OF THE GOVERNOR. CITY HALL BUILDING IS CLOSED TO THE PUBLIC FOR THE PURPOSE OF THE PUBLIC’S ATTENDANCE AT THE MEETING TO ENSURE COMPLIANCE WITH THE CDC GUIDELINES AND STATE AND COUNTY ORDERS PERTAINING TO SOCIAL DISTANCING.

PROPOSED ORDINANCE:

AN ORDINANCE OF THE CITY OF NORTH LAUDERDALE FLORIDA PERTAINING TO WATER CONSERVATION; REPEALING AND REPLACING SECTION 70-32 ENTITLED “WATER SHORTAGE/EMERGENCY PLAN”; TO PROVIDE AN UPDATED WATER SHORTAGE PLAN CONSISTENT WITH THE REQUIREMENTS OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT; REPEALING AND REPLACING SECTION 70-35 ENTITLED “WATER CONSERVATION PLANS”; TO PROVIDE AN UPDATED WATER CONSERVATION PLAN CONSISTENT WITH THE REQUIREMENTS OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT; PROVIDING THE INTENT AND PURPOSE; PROVIDING DEFINITIONS; PROVIDING FOR THE APPLICABILITY OF THE ORDINANCE; PROVIDING FOR THE DECLARATION OF WATER SHORTAGE OR WATER SHORTAGE EMERGENCY; PROVIDING FOR VARIANCES; PROVIDING FOR ENFORCEMENT; PROVIDING FOR PENALTIES; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

ANYONE WISHING TO SPEAK FOR OR AGAINST THE PROPOSED ACTION IS INVITED TO ATTEND THE MEETING. ALL AFFECTED PERSONS WILL BE ALLOWED TO PRESENT EVIDENCE AT THE HEARING, BRING FORTH WITNESSES AND CROSS-EXAMINE WITNESSES PROVIDED THEY NOTIFY AND FILE THE REQUIRED FORMS PROVIDED BY THE CITY CLERK’S OFFICE, AT LEAST SEVEN CALENDAR DAYS PRIOR TO THE PROCEEDING.
