**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO ENTER INTO AN AGREEMENT BETWEEN THE CITY OF NORTH LAUDERDALE AND COAST TO COAST GARAGE DOOR, LLC. FOR BID AWARD OF FIRE STATION 34 & 44 APPARATUS BAY DOORS ITB 20-04-393, IN AN AMOUNT NOT TO EXCEED \$552,184.00 FOR; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of North Lauderdale applied for the Federal Emergency Management Agency (FEMA) Hazard Mitigation Grant Program (HMGP) which provides a process for municipalities to apply for project funding to retrofit existing facilities in order to withstand hurricane force wind loads; and

**WHEREAS**, the City's Fire Rescue Station 34 & 44 serve as critical infrastructure for the City as well as the neighboring cities of Margate and Tamarac. Both stations are committed to preserving the lives and property, as well as ensuring the health, safety, and welfare, of the residents and general public; and

**WHEREAS**, Fire Station 44 requires structural and hardening enhancements because it's not impact rated to withstand high-velocity wind speed situations. Fire Station 34 requires the replacement of the existing rollup doors with bi-fold hardened apparatus bay doors. The front of the buildings with have bi-fold doors whereas the back of the buildings will have roll-up doors; and

**WHEREAS**, the City's application was selected and awarded January 18, 2019, receiving \$987,010 from FEMA's Hazard Mitigation Grant Program which includes the City's required contribution of a 25% match (\$246,752.50). A portion will be used towards this Apparatus Bay Doors project

**WHEREAS**, the City of North Lauderdale received a total of 3 bid packages for the Fire Station 34 & 44 Apparatus Bay project for consideration. After review, Coast to Coast Garage Door, LLC. were deemed the lowest and most responsive bidder at a cost of \$552,184.00

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA, THAT:**

**SECTION 1.** "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and incorporated herein by this reference.

**SECTION 2.** That the Commission authorizes the City Manager or her designee to enter into an agreement between the City of North Lauderdale and Coast to Coast Garage Door, LLC. for bid award of the Fire Station 34 & 44 Apparatus Bay Doors ITB 20-04-393, in an amount not to exceed \$552,184.00.

**SECTION 3.** That the funding for this project in the amount not to exceed \$552,184.00 has been appropriated in fiscal year 2020.

**SECTION 4:** If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or in application, it shall not affect validity of the remaining portion or applications of this Resolution.

**SECTION 5:** That this Resolution shall take effect immediately upon its passage and adoption.
