NOTICE OF PUBLIC HEARING
PROPOSED ORDINANCES

THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA WILL CONSIDER THE FOLLOWING PROPOSED ORDINANCES AT THEIR MEETING ON TUESDAY, MAY 12, 2020 AT 6:00 PM, WHICH WILL BE CONDUCTED VIRTUALLY UTILIZING COMMUNICATIONS MEDIA TECHNOLOGY (CMT) IN ACCORDANCE WITH GOVERNOR'S EXECUTIVE ORDER NO. 20-69, DATED 3-20-2020 RELATED TO THE CORONA VIRUS DISEASE.

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA, AMENDING ORDINANCE NO. 19-09-1394 BY WHICH THE CITY COMMISSION DID ADOPT THE BUDGET OF THE CITY OF NORTH LAUDERDALE FOR THE 2019/20 FISCAL YEAR, TO REVISE THE BUDGET AS DOCUMENTED IN "EXHIBIT A" ATTACHED BY \$455,730 FOR THE REMAINING CONTRACT COSTS FOR THE ADA TRANSITION PLAN AND THE STORMWATER MASTER PLAN, FOR THE COST OF TEMPORARY STAFFING; PROVIDING FOR CONFLICTS, SEVERABILITY, AND, PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF NORTH LAUDERDALE, FLORIDA, AMENDING CHAPTER 2, "ADMINISTRATION," ARTICLE II, "GOVERNING BODY," DIVISION 1, "GENERALLY," OF THE CITY'S CODE OF ORDINANCES BY SPECIFICALLY CREATING SECTION 2-37, TO BE ENTITLED "DONATION POLICY OF CITY COMMISSION"; PROVIDING FOR POLICIES AND PROCEDURES REGULATING THE DONATION POLICY OF THE CITY COMMISSION; PROVIDING FOR DIRECTION TO THE CITY MANAGER; PROVIDING DIRECTION TO THE CITY CLERK; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF NORTH LAUDERDALE, FLORIDA, PURSUANT TO SECTION 3.9(A) OF THE CITY OF NORTH LAUDERDALE CHARTER, AUTHORIZING THE SALE OF REAL PROPERTY LOCATED AT 1880 SW 62ND AVENUE, WHICH IS BEING DONATED TO THE CITY BY THE BROADVIEW COUNTRY CLUB ESTATES CIVIC ASSOCIATION, IN ACCORDANCE WITH THE PURCHASE AND SALE AGREEMENT APPROVED BY THE CITY COMMISSION THROUGH RESOLUTION 2020-04-6742, AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
