NOTICE OF PUBLIC HEARING  
PROPOSED ORDINANCES

The City of North Lauderdale City Commission will be conducting a “Virtual” City Commission meeting ON Monday, September 14, 2020 at 6:00 pm, utilizing communications media technology (“CMT”), in accordance with Governor Ron DeSantis’ Executive Order No. 20-69, dated March 20, 2020, related to conducting local government public meetings while under the public health emergency related to the spread of Novel Coronavirus Disease 2019 (COVID-19). The conducting of virtual meetings is subject to potential change or modification and reversion to non-virtual, in-person public meetings under Ch. 286, FS, dependent upon Executive Orders of the Governor. City Hall building is closed to the public.
