The qualifications for membership on the planning and zoning board shall be as follows:

(2) The applicant should be well-versed in environmental, planning and zoning matters, have the ability to interpret architectural drawings, zoning regulations, city land use plan, comprehensive plan and should be sympathetic to municipal development consonant with the health, safety and welfare of its residents.

(3) At least five members of the board should have one of the following qualifications as evidence of their ability to work on the board:

- a. Employed in a site planning, engineering, building inspector or similar profession.
- b. Employed by a private or public company in a long or short range planning capacity in a position that demonstrates the member's ability to do constructive planning.
- c. General contractor's license.
- d. Member of the bar association.
- e. Certified public accountant or bachelor's degree in accounting.
- f. Registered architect's license.
- g. Professional engineer's license.
- h. Engineering intern or engineer-in-training certificate.

i. Real estate broker.

j. Employed in a profession not previously mentioned that, in the opinion of a majority of the governing body, demonstrates the competence of the applicant and thereby qualifies that person for membership to the board.

k. No board member shall hold any elective public office of the city, or be employed by the city in any capacity.

**CODE ENFORCEMENT BOARD\***

**Sec. 2-262. - Qualifications for membership.**

(1) Commitment to the community;

(2) Actual experience and exposure to the categories of membership set forth in section 2-261;

(3) Availability for meetings, conferences, and appearances before the city commission;

(4) Operation of a business or business entity conducted within the city, or surrounding communities, for the purpose of knowledge and understanding of the needs and requirements of the city in effectuating the purposes of this code enforcement article;

**COMMUNITY SUSTAINABILITY BOARD**

**Sec. 78-103. - Qualifications of membership.**

(2) The governing body shall endeavor to appoint members who are local business persons doing business in the city and who possess occupational licenses issued by the city.

(d) If possible, the members of the board shall include a real estate professional, banking/finance professional, business owner/operator or owner/manager of commercial/industrial property, architect/engineering professional or general contractor, and knowledgeable person in the field of agriculture, gardening or horticulture.

**HOUSING AUTHORITY**

**Sec. 82-203. - Appointment, qualifications, and tenure of commissioners; hiring of employees..**

(b) The authority shall have at least one commissioner who shall be a resident and who is currently in rent in a housing project or a person of low or very income who resides within the authority's jurisdiction and who is receiving rental subsidy through a program administered by the authority's public housing agency within its jurisdiction of North Lauderdale and serviced by the authority, which commissioner shall be appointed at the time a vacancy exists.
