This meeting was held virtually utilizing Communications Media Technology (CMT) in accordance with Governor Ron DeSantis' Executive Order No. 20-69, dated March 20, 2020, related to conducting local government public meetings while under the public health emergency related to the spread of Novel Coronavirus Disease 2019 (COVID-19). The conducting of virtual meetings is subject to potential change or modification and reversion to non-virtual, in-person public meetings under Ch. 286, FS, dependent upon Executive Orders of the Governor. City Hall building is closed to the public.

James Williams, Purchasing Manager, opened the meeting at 2:09 pm on Wednesday, August 19, 2020. The solicitation for Invitation to Bid ITB #20-07-401 for Rock Island Road Intersection Improvements. This solicitation was released on July 24, 2020. Sealed responses were due in the office of the City Clerk of North Lauderdale, Florida, 2:00 pm EST, Wednesday, August 19, 2020. No late submissions were accepted. There was a Non-Mandatory Pre-Bid Meeting held on July 27, 2020. There was one (1) addendum posted for this project and acknowledgment of receipt of the addendum is required; failure to acknowledge the addendum may result in rejection of proposals.

Mr. Williams stated the sealed responses received by the City will be opened and read into the Minutes and this process does not constitute an award or recommendation for award. After this closing, the responses will be reviewed for responsiveness by the Purchasing Division. Sealed proposals were opened in no particular order and documented as follows:

1. **Florida Blacktop, Inc.** – 1 flash drive submitted; 1 addendum acknowledged; total price - **\$148,371.60**
2. **E & F Florida Enterprises Inc.** – 1 flash drive submitted; 1 addendum acknowledged; total price - **\$142,942.60**
3. **Weekley Asphalt Paving** - 1 flash drive submitted; 1 addendum acknowledged; total price - **\$212,054.041**
4. **Heavy Civil, Inc.** - 1 flash drive submitted; 1 addendum acknowledged; total price – **\$153,000.00**
5. **FG Construction, LLC** - 1 flash drive submitted; 1 addendum acknowledged; total price – **\$128,032.42**

Mr. Williams stated that after review by the City Staff, a Notice of Intent to Award or to reject will be posted on DemandStar and the City's website. It is anticipated that the recommendation may be submitted to City Commission for award on Tuesday, September 8, 2020. He commented that a Cone of Silence is still in effect for this solicitation.
