MINUTES OF OPENING OF SEALED RESPONSES
VIRTUAL MEETING
May 27, 2020

This meeting was held virtually utilizing Communications Media Technology (CMT) in accordance with Governor Ron DeSantis' Executive Order No. 20-69, dated March 20, 2020, related to conducting local government public meetings while under the public health emergency related to the spread of Novel Coronavirus Disease 2019 (COVID-19). The conducting of virtual meetings is subject to potential change or modification and reversion to non-virtual, in-person public meetings under Ch. 286, FS, dependent upon Executive Orders of the Governor. City Hall building is closed to the public.

Danielle Keira-Cancel, Purchasing Coordinator, opened the meeting at 10:03 am EST on Wednesday, May 27, 2020. The solicitation for Invitation to Bid ITB #20-04-393 for Fire Station 34 & 44 Apparatus Bay Doors -HMGP was released on April 27, 2020. Responses were due by 10:00 am; no late submissions were accepted.

Ms. Keira-Cancel indicated that she would open and document the sealed responses received and stated that this process does not constitute an award or recommendation for award. After the opening, the responses will be reviewed for completeness by the Purchasing Division and forwarded to Public Works for review. Two addenda were posted for this project and failure to acknowledge the addenda may result in rejection of the bid. A Notice of Information was also released. Sealed responses received were opened in no particular order and documented as follows:

1. West Construction, Inc.
1 flash drive submitted with 1 original and 5 hard copies; both Addenda were acknowledged and a bid bond for 5% was received
Pricing: \$844,030

2. Coast to Coast Garage Doors LLC
1 flash drive submitted with 1 original and 3 hard copies; both Addenda were acknowledged and a bid bond was received
Pricing: \$552,184

3. Waypoint Contracting, Inc.

1 flash drive submitted with 1 original and 3 hard copies; both Addenda were acknowledged and a bid bond was received

Pricing: \$732,940

For the record, the pricing was not read into the record at the time of the bid opening but has been added to these minutes.

Ms. Keira-Cancel advised that after the responses are reviewed by the Evaluation Committee a notice of intent to award or reject will be posted on DemandStar and the City's website. It is anticipated that a recommendation will be submitted to the City Commission for award on Tuesday, June 9, 2020. A cone of silence is in effect for this solicitation.
