A RESOLUTION OF THE CITY OF NORTH LAUDERDALE, FLORIDA AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO ENTER INTO AN AGREEMENT WITH L J POWER INC. FOR THE PURCHASE OF SIX PORTABLE GENERATORS FOR LIFT STATIONS AS OUTLINED IN BID #20-01-389 IN AN AMOUNT NOT TO EXCEED \$367,500.00; PROVIDING FOR FUNDING AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City applied for and received a grant from the Hazard Mitigation Grant Program (HMGP) through the Florida Division of Emergency Management Division and the Federal Emergency Management Agency (FEMA) in the amount of \$570,000.00 for the purchase of portable generators; and

WHEREAS, THE City issued an Invitation To Bid (ITB# 20-01-389) and

WHEREAS, L J Power Inc. was identified as the lowest, responsible bidder; and

WHEREAS, City Administration recommends entering into an agreement with L J Power Inc. for the purchase of six (6) portable generators for lift stations under ITB # 20-01-0389 in an amount not to exceed \$367,500.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA:

SECTION 1: The foregoing "WHEREAS" clauses are true and correct, and hereby ratified and confirmed by the City Commission and incorporated herein.

SECTION 2: That the bids for the project were obtained through the Notice of Invitation To Bid # 20-01-389

SECTION 3: That L J POWER Inc. has been deemed the lowest responsive, responsible bidder

SECTION 4: That the City Commission of the City of North Lauderdale, Florida authorizes the City Manager or her designee to enter into an agreement with L J Power Inc. for the purchase of six portable generators for lift stations under bid # 20-01-389 in an amount not to exceed \$367,500.00

SECTION 5: All resolutions or part of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

SECTION 5: That this Resolution shall take effect immediately upon adoption.
