

ORDINANCE NO. 20-05-1400

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA, AMENDING ORDINANCE NO. 19-09-1394 BY WHICH THE CITY COMMISSION DID ADOPT THE BUDGET OF THE CITY OF NORTH LAUDERDALE FOR THE 2019/20 FISCAL YEAR, TO REVISE THE BUDGET AS DOCUMENTED IN "EXHIBIT A" ATTACHED BY \$455,730 FOR THE REMAINING CONTRACT COSTS FOR THE ADA TRANSITION PLAN AND THE STORMWATER MASTER PLAN, FOR THE COST OF TEMPORARY STAFFING; PROVIDING FOR CONFLICTS, SEVERABILITY, AND, PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the City Commission for the City of North Lauderdale adopted the 2019/20 Fiscal Year Budget for the City of North Lauderdale through the adoption of Ordinance 19-09-1394; and,

WHEREAS, the City Commission desires to amend Ordinance 19-09-1394 to reflect revisions to the budget for the 2019/20 Fiscal Year Budget; and,

WHEREAS, the City Commission finds it to be in the best interest of the residents and citizens of the City of North Lauderdale to amend the Fiscal Year 2019/20 budget as provided herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA:**

Section 1: That the foregoing "Whereas" clauses are adopted as if fully set forth herein.

Section 2: That Ordinance 19-09-1394 as amended, did adopt the Budget of the City of North Lauderdale for the 2019/20, and the Budget adopted thereby be and the same is hereby amended to cause and reflect revisions to said Budget as set forth in Exhibit "A".

Section 3: That the City Commission finds it to be in the best interest of the residents and citizens of the City of North Lauderdale to amend the Fiscal Year 2019/20 budget as provided herein.

Section 4: That all Ordinances or parts of Ordinances, Resolutions or parts of Resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.


Section 5: Should any section or any provision of this Ordinance or portion hereof, any paragraph, sentence, or work be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the remainder of this Ordinance.

Section 6: That this Ordinance shall take effect immediately upon adoption.


